ASAJ SANCTION #: 42422

VENUE: National Stadium Pool 8-Lane 50 M competition pool

(with 25 M warm up pool)

Colorado Electronic Timing System (CTS6): pads with back-up buttons

DATES & TIMES: Saturday November 9, 2024 8:30 a.m. & 2:30 p.m.

Pool will be opened 1½ (one and a half) hours before starting time.

If there are insufficient entries, the two (2) sessions will be merged with a 30-minute break between Events 6 and 7. If the sessions are to be merged, this

will be communicated by November 6, 2024.

ELIGIBILITY: All Clubs and Swimmers, in good standing, registered with the ASAJ or other

World Aquatics-affiliated Federations. Age groups according to the swimmer's age as at **December 31**st, **2023**. Swimmers must **NOT** have achieved an 'A' time or better in the event(s) in which they have been entered.

REGISTRATION: The ASAJ register closes on October 18, 2024 at 4:00pm

ENTRY LIMITS: Maximum number of events per swimmer – Three (3)

Minimum age for OPEN events: 10 years old. Minimum age for 10&U events: 8 years old.

The Meet Director reserves the right to change meet warm-up, start times, or drop/move heats and/or events, add breaks in order to hold an

efficient meet

ENTRY FEES: N.B. ENTRIES SHOULD BE SUBMITTED VIA HY-TEK SOFTWARE.

J\$500 per swimmer per individual event

J\$500 per swimmer surcharge

Entry fees are to be paid by November 6, 2024. This will be strictly

enforced.

Date of birth for each swimmer must be included in the entry file.

ENTRY DEADLINE: Friday, November 1, 2024 by 11:59 PM. Entries should be submitted to

asajswimmeets@gmail.com

RULES: World Aquatics Rules and ASAJ By-Laws in force at the time of the

competition will apply. World Aquatics Starting rule SW 4 will apply - Any swimmer starting before the starting signal has been given, shall be

disqualified. See additional Rules and Regulations below.



PROGRAMME: All events will be swum as timed finals. See attached programme.

ADDITIONAL RULES: Competitors will only be allowed to swim in their age group. If competitors

swim outside of their age group, the offending swimmer will be disqualified

from the competition.

Deck entries and time trials will **NOT** be allowed.

Substitutions will **NOT** be allowed. Offending swimmers will be disqualified

from the competition.

SEEDING: All entries will be seeded with entry times. 100M NT times should be

submitted according to the formula: 50M time x 1.25 x z 0.200M and up NT times should be submitted according to the formula: 50M time x 1.4 x #laps. 400IM NT times should be submitted according to the formula: 200IM time x 1.25 x z 0.200M so serious be scratched if the timeline indicates a session

duration in excess of 4 hours.

POSITIVE CHECK-IN: Positive check-in is required for events 400M and above and will end 20

minutes before the start of each session.

MARSHALLING: There will be no Marshalling Area for the meet. The next heat must be behind

the blocks while the current heat is in progress.

The coaches are responsible to get their swimmers to the starting block. It is the responsibility of the swimmer to swim in the correct lane and heat assigned to him/her. If a swimmer swims in the wrong lane or heat then the swimmer

will automatically be disqualified.

Once the swimmers are under the starter's orders and he has taken control of the race (after second whistle), no swimmer may then enter the race. If this

occurs, the swimmer will be disqualified and not allowed to swim.

Protests All protests to the Referee's decision must be submitted to the Referee

in writing within 30 minutes after the announcement of a disqualification, signed by the Team Manager or Head Coach and accompanied by J\$1,500. If the protest is upheld the fee will be returned

to the Club.

Jury of AppealA. There shall be a Jury of Appeal to adjudicate all appeals against a

Referee's rejection of a protest.

B. Each Club shall be entitled to nominate a representative to serve on the Jury of Appeal. Nominations will be submitted in writing along

with the entries.



C. The Jury of Appeal shall comprise 3 persons drawn from the pool of nominees submitted by each Club.

SCORING AND AWARDS: The Meet will **NOT** be scored and awards will **NOT** apply.
